The digital world is powered by APIs that allow for seamless interactions between IT systems over standard specifications.

Primary Market Issuance (PMI) API

The PMI API enables market participants to request ISINs and to deliver instrument data for ISIN activation in a fully digitised debt issuance process. Additional features of the new PMI API include allocation of the associated common code, CFI (Classification of Financial Instrument) and FISN (Financial Instrument Short Name) identifiers of the securities.

Clearstream API Services

The PMI API leverages the Clearstream API Services as well as Airbrush, an open interface data standard

for defining and communicating a new fixed income security to one another. The Clearstream API platform exposes business and technical data directly to the IT systems of our customers.

- Integration of customer systems with multiple APIs across products in a seamless and secure manner
- Customers' IT teams to develop specialised and customised software based on our API offering
- State-of-the-art interface experience by reducing the reliance on traditional interfaces

Digitised debt issuance

Clearstream's vision is to provide the functionality and technical architecture for a zero-touch, same day, fully digitised and standardised debt issuance process. In a first step Clearstream is integrating origination workflows from Clearstream's issuance partners via the REST (Representational State Transfer) API.

Fast and scalable: REST API

The architectural style of the REST API is designed to take advantage of HTTP as a network-based API. The REST API technology can quickly establish a secure communication channel with minimum effort. Using our proven security mechanisms, the API will facilitate the automation of existing manual processes and enable real-time services.

Our REST API services seek to expose and leverage existing utility within the issuance ecosystem and offer our partners scalable, modular and rapid solutions.

Connecting with Xact

Our REST API is leveraging our existing Xact technology platform for authentication, encryption, authorisation and general user management.

Functional scope

The below features are foreseen within Clearstream's API services:

- Code Allocation: (Common code, XS-ISIN, LU-ISIN) and associated CFI + FISN
- ICSD Admission: providing automated validation from operational and tax perspectives, and in future enhancements
- Monitoring of the settlement process
- Value-added and data-based services.

Access to the PMI API

The PMI API is accessible via the Xact Web Portal at the endpoints listed in the below table:

Access requirements

Access to the PMI API requires the completion and acceptance of Clearstream's API Agreement with the PMI API Annex including subscription to Clearstream's connectivity suite (Xact Web Portal). Xact Web Portal provides self-management of the PMI API credentials, providing the digital certificate necessary to authenticate the PMI API service.

A monthly invoice detailing the services is made available using the Electronic Invoice Distribution service. Access to the Deutsche Börse Billing Portal subscription provides copies of the invoices.
